

# Invitation for Bids

- The Government of Mongolia has received financing from the Asian Development Bank (ADB) toward the cost of the Regional Road Development and Maintenance Project Phase 3. Part of this financing will be used for payments under the Contracts named above. Bidding is open to Bidders from eligible source countries of ADB.
- The Ministry of Road and Transport Development (“the Employer”) invites sealed bids from eligible Bidders for the Construction of a new asphalt paved road for the section from Myangad to the intersection with Naranbulag – Ulaangom road (163km) (“the Works”). The package is bid in 3 contracts. Bidders may bid for anyone, more than one, or all of the Contracts. The procurement will be undertaken by the State Procurement Agency (SPA) on behalf of the Employer.
