**Tender clarification**

  - 2.3. Bidder's claim or complaint is found to be completely invalid or unreasonable by state central organization in charge of budget-related matters.
3. In the event that any of the circumstances above arises and immediately after Client's demand to make payments, Guarantor shall transfer such an amount to a corresponding bank account of state central organization. An amount to be paid by Guarantor shall not exceed the amount as per clause 1 of this letter of guarantee.
4. This Letter of Guarantee shall be valid for a period of 28 days from the bid expiration date.
5. Any claim or demand to be notified in accordance with this letter of guarantee shall be informed to Guarantor within the valid term.
6. Guarantor may invalidate this letter of guarantee prior to its expiration date based on Client's permission in the events of following:
  - 6.1. Bidder acknowledges Client's decision to avoid the Bids;
  - 6.2. Conclusion of agreement in the Bids selection.
7. Guarantor shall be held responsible for the invalidation of this letter of guarantee by reasons other than specified above.
