Section I - Instructions to Applicants (ITA)

A.General

- 1. Scope of Application
- 1.1 In connection with the invitation for Initial Selection indicated in Section II, Initial Selection Data Sheet (ISDS), the Employer, as defined in the ISDS, issues this Initial Selection Document ("Initial Selection Document") to prospective applicants ("Applicants") interested in submitting applications ("Applications") for Initial Selection to submit Proposals for the Works Design and Build described in Section VII, Scope of Employer's Requirement. In case proposals for the Works Design and Build are to be invited as individual contracts (i.e., the slice and package procedure), these are listed in the ISDS. The Request for Proposals (RFP) number corresponding to this Initial Selection is also provided in the ISDS.
- 2. Source of Funds
- 2.1 The Borrower or Recipient (hereinafter called "Borrower") indicated **in the ISDS** has applied for or received financing (hereinafter called "funds") from the International Bank for Reconstruction and Development or the International Development Association (hereinafter called "the Bank") in an amount specified **in the ISDS**, towards the cost of the project named **in the ISDS**. The Borrower intends to apply a portion of the funds to eligible payments under the contract(s) resulting from the Request for Proposals (RFP) process for which this Initial Selection is conducted.
- 2.2 Payment by the Bank will be made only at the request of the Borrower and upon approval by the Bank, and will be subject, in all respects, to the terms and conditions of the Loan (or other financing) Agreement. The Loan (or other financing) Agreement prohibits a withdrawal from the loan (or credit) account for the purpose of any payment to persons or entities, or for any import of goods, equipment, plant or materials, or services if such payment or import, to the knowledge of the Bank, is prohibited by a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations. No party other than the Borrower shall derive any rights from the Loan (or other financing) Agreement or have any claim to the proceeds of the loan (or credit).
- 3. Fraud and Corruption
- 3.1 The Bank requires compliance with the Bank's Anti-Corruption Guidelines and its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as set forth in Section VI, Fraud and Corruption.
- 3.2 In further pursuance of this policy, Applicants shall permit and shall cause their agents (where declared or not), subcontractors, subconsultants, service providers, suppliers, and personnel, to permit the Bank to inspect all accounts, records and other

documents relating to any Prequalification process, Initial Selection process, Bid submission (in case prequalified), Proposal submission (in case initially selected) and contract performance (in the case of award), and to have them audited by auditors appointed by the Bank.

4. Eligible Applicants

- 4.1 Applicants shall meet the eligibility criteria as per this Instruction and ITA 5.1.
- 4.2 An Applicant may be a firm that is a private entity, a state-owned enterprise or institution subject to ITA 4.9 or any combination of such entities in the form of a joint venture ("JV") under an existing agreement or with the intent to enter into such an agreement supported by a letter of intent. In the case of a joint venture, all members shall be jointly and severally liable for the execution of the entire Contract in accordance with the Contract terms. The JV shall nominate an authorized representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the Initial Selection process, RFP process (in the event the JV submits a Proposal) and during contract execution (in the event the JV is awarded the Contract). Unless specified in the ISDS, there is no limit on the number of members in a JV.
- 4.3 A firm is not permitted to participate for initial selection for the same contract both as an individual firm and as a part of a joint venture or as a subcontractor. However, a firm may participate as a subcontractor in more than one Application but only in the capacity of a subcontractor. Applications submitted in violation of this procedure will be rejected
- 4.4 A firm and any of its affiliates (that directly or indirectly control, are controlled by or are under common control with that firm) are not permitted to submit more than one application for initial selection for the same contract, either individually, as joint venture or as a subcontractor among them. Applications submitted in violation of this procedure will be rejected.
- 4.5 An Applicant may have the nationality of any country, subject to the restrictions pursuant to ITA 5.1. An Applicant shall be deemed to have the nationality of a country if the Applicant is constituted, incorporated or registered in and operates in conformity with the provisions of the laws of that country, as evidenced by its articles of incorporation (or equivalent documents of constitution or association) and its registration documents, as the case may be. This criterion also shall apply to the determination of the nationality of proposed specialized sub-contractors or suppliers for any part of the Contract including related Services.
- 4.6 Applicants and proposed specialized sub-contractors or suppliers for any part of the Contract including related services (for the purpose of this ITA 4.6 referred to as "Applicants") shall not have a conflict of interest. Applicants shall be

considered to have a conflict of interest, if they, or any of their affiliates, participated as a consultant in the preparation of the Employer's Requirement (other than design to be carried out as part of this Works Design and Build contract) or have been hired or proposed to be hired by the Employer or Borrower as Engineer for contract implementation of the Works Design and Build that are the subject of this Initial Selection. In addition, Applicants may be considered to have a conflict of interest if they have a close business or family relationship with a professional staff of the Borrower (or of the project implementing agency, or of a recipient of a part of the loan) who: (i) are directly or indirectly involved in the preparation of the Initial Selection Document or Request for Proposals (RFP) Document or specifications of the Contract, and/or the Proposal evaluation process of such Contract; or (ii) would be involved in the implementation or supervision of such Contract, unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the procurement process and execution of the Contract.

- 4.7 An Applicant that has been sanctioned by the Bank, pursuant to the Bank's Anti-Corruption Guidelines, and in accordance with its prevailing sanctions policies and procedures as set forth in the WBG's Sanctions Framework, as described in Section VI, paragraph 2.2 d. shall be ineligible to be prequalified for, initially selected for, bid for, propose for or be awarded a Bankfinanced contract or benefit from a Bank-financed contract, financially or otherwise, during such period of time as the Bank shall have determined.
- 4.8 The list of debarred firms and individuals is available as specified in the ISDS.
- 4.9 Applicants that are state-owned enterprise or institutions in the Employer's Country may be eligible to be initially selected, compete and be awarded a Contract(s) only if they can establish, in a manner acceptable to the Bank, that they (i) are legally and financially autonomous (ii) operate under commercial law, and (iii) are not under supervision of the Employer.
- 4.10 An Applicant shall not be under suspension from bidding or submitting proposals by the Employer as the result of the execution of a Bid or Proposal–Securing Declaration.
- 4.11 An Applicant shall provide such documentary evidence of eligibility satisfactory to the Employer, as the Employer shall reasonably request.
- 4.12 A firm that is under a sanction of debarment by the Borrower from being awarded a contract is eligible to participate in this

procurement, unless the Bank, at the Borrower's request, is satisfied that the debarment:

- (a) relates to fraud or corruption; and
- (b) followed a judicial or administrative proceeding that afforded the firm adequate due process.

- 5. Eligibility
- 5.1 Firms and individuals may be ineligible if they are nationals of ineligible countries as indicated in Section V. The countries, persons or entities are ineligible if (a) as a matter of law or official regulations, the Borrower's country prohibits commercial relations with that country, provided that the Bank is satisfied that such exclusion does not preclude effective competition for the supply of goods or the contracting of works or services required; or (b) by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of goods or contracting of works or services from that country, or any payments to any country, person, or entity in that country. When the Works Design and Build is implemented across jurisdictional boundaries (and more than one country is a Borrower, and is involved in the procurement), then exclusion of a firm or individual on the basis of ITA 5.1(a) above by any country may be applied to that procurement across other countries involved, if the Bank and the Borrowers involved in the procurement agree.

B. Contents of the Initial Selection Document

6. Sections of Initial Selection Document

6.1 This Initial Selection Document consists of parts 1 and 2 which comprise all the sections indicated below, and which should be read in conjunction with any Addendum issued in accordance with ITA 8.

PART 2 Employer's Requirements

- Section VII Scope of Employer's Requirement
- 6.2 Unless obtained directly from the Employer, the Employer accepts no responsibility for the completeness of the document, responses to requests for clarification, the minutes of the pre-Application meeting (if any), or Addenda to the Initial Selection Document in accordance with ITA 8. In case of any discrepancies, documents issued directly by the Employer shall prevail.
- 6.3 The Applicant is expected to examine all instructions, forms, and terms in the Initial Selection Document and to furnish with its Application all information or documentation as is required by the Initial Selection Document.
- 7. Clarification of Initial Selection Document and Pre-Application Meeting
- 7.1 An Applicant requiring any clarification of the Initial Selection Document shall contact the Employer in writing at the Employer's address indicated **in the ISDS.** The Employer will respond in writing to any request for clarification provided that such request is received no later than fourteen (14) days prior to the deadline for submission of the applications. The Employer shall forward a copy of its response to all prospective Applicants who have obtained the Initial Selection Document directly from the Employer, including a description of the inquiry but without identifying its source. If so indicated **in the ISDS**, the Employer shall also promptly publish its response at the web page identified **in the ISDS**. Should the Employer deem it necessary to amend the Initial Selection Document as a result of a clarification, it shall do so following the procedure under ITA 8 and in accordance with the provisions of ITA 17.2.
- 7.2 If indicated **in the ISDS**, the Applicant's designated representative is invited at the Applicant's cost to attend a pre-Application meeting at the place, date and time mentioned **in the ISDS**. During this pre-Application meeting, prospective Applicants may request clarification of the project requirement, the criteria for qualifications or any other aspects of the Initial Selection Document.
- 7.3 Minutes of the pre-Application meeting, if applicable, including the text of the questions asked by Applicants, including those during the meeting (without identifying the source) and the responses given, together with any responses prepared after the meeting will be transmitted promptly to all prospective Applicants who have obtained the Initial Selection Document. Any modification to the Initial Selection Document that may become necessary as a result of the pre-Application meeting shall be made by the Employer exclusively through the use of an Addendum pursuant to ITA 8. Non-attendance at the pre-Application meeting will not be a cause for disqualification of an Applicant.

8. Amendment of Initial Selection Document

- 8.1 At any time prior to the deadline for submission of Applications, the Employer may amend the Initial Selection Document by issuing an Addendum.
- 8.2 Any Addendum issued shall be part of the Initial Selection Document and shall be communicated in writing to all Applicants who have obtained the Initial Selection Document from the Employer. The Employer shall promptly publish the Addendum at the Employer's web page identified in the ISDS.
- 8.3 To give Applicants reasonable time to take an Addendum into account in preparing their Applications, the Employer may, at its discretion, extend the deadline for the submission of Applications in accordance with ITA 17.2.

C. Preparation of Applications

- 9. Cost of Applications
- 9.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Employer will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the Initial Selection process.
- 10. Language of Application
- 10.1 The Application as well as all correspondence and documents relating to the Initial Selection exchanged by the Applicant and the Employer, shall be written in the language specified **in the ISDS.** Supporting documents and printed literature that are part of the Application may be in another language, provided they are accompanied by an accurate translation of the relevant passages in the language specified **in the ISDS**, in which case, for purposes of interpretation of the Application, the translation shall govern.
- 11. Documents
 Comprising the
 Application
- 11.1 The Application shall comprise the following:
 - (a) **Application Submission Letter**, in accordance with ITA 12.1;
 - (b) **Eligibility:** documentary evidence establishing the Applicant's eligibility, in accordance with ITA 13.1;
 - (c) **Qualifications:** documentary evidence establishing the Applicant's qualifications, in accordance with ITA 14; and
 - (d) any other document required as specified in the ISDS.
- 11.2 The Applicant shall furnish information on commissions and gratuities, if any, paid or to be paid to agents or any other party relating to this Application
- 12. Application Submission Letter
- 12.1 The Applicant shall complete an Application Submission Letter as provided in Section IV, Application Forms. This Letter must be completed without any alteration to its format.

- 14. Documents
 Establishing the
 Qualifications of the
 Applicant
- 13.1 To establish its eligibility in accordance with ITA 4, the Applicant shall complete the eligibility declarations in the Application Submission Letter and Forms ELI (eligibility) 1.1 and 1.2, included in Section IV, Application Forms.
- 14.1 To establish its qualifications to perform the contract(s) in accordance with Section III - Initial Selection Criteria and Requirements, the Applicant shall provide the information requested in the corresponding Information Sheets included in Section IV, Application Forms.
- 14.2 Wherever an Application Form requires an Applicant to state a monetary amount, Applicants should indicate the USD equivalent using the rate of exchange determined as follows:
 - (a) for construction turnover or financial data required for each year - exchange rate prevailing on the last day of the respective calendar year (in which the amounts for that year are to be converted); and
 - (b) value of single contract exchange rate prevailing on the date of the contract.

Exchange rates shall be taken from the publicly available source identified **in the ISDS**. Any error in determining the exchange rates in the Application may be corrected by the Employer.

- 15. Signing of the Application and Number of Copies
- 15.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 11 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by an authorized representative of the JV on behalf of the JV and so as to be legally binding on all the members as evidenced by a power of attorney signed by their legally authorized signatories.
- 15.2 The Applicant shall submit copies of the signed original Application, in the number specified **in the ISDS**, and clearly mark them "COPY". In the event of any discrepancy between the original and the copies, the original shall prevail.

D. Submission of Applications

- 16. Sealing and Marking of Applications
- 16.1 The Applicant shall enclose the original and the copies of the Application in a sealed envelope that shall:
 - (a) bear the name and address of the Applicant;
 - (b) be addressed to the Employer, in accordance with ITA 17.1; and
 - (c) bear the specific identification of this Initial Selection

process indicated in the ISDS 1.1.

- 16.2 The Employer will accept no responsibility for not processing any envelope that was not identified as required in ITA 16.1 above.
- 17. Deadline for Submission of Applications
- 17.1 Applicants may either submit their Applications by mail or by hand. Applications shall be received by the Employer at the address and no later than the deadline indicated **in the ISDS**. When so specified **in the ISDS**, Applicants have the option of submitting their Applications electronically, in accordance with electronic Application submission procedures specified **in the ISDS**.
- 17.2 The Employer may, at its discretion, extend the deadline for the submission of Applications by amending the Initial Selection Document in accordance with ITA 8, in which case all rights and obligations of the Employer and the Applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.
- 18. Late Applications
- 18.1 The Employer reserves the right to accept applications received after the deadline for submission of applications, unless otherwise specified in the ISDS.
- 19. Opening of Applications
- 19.1 The Employer shall open all Applications at the date, time and place specified **in the ISDS**. Late Applications shall be treated in accordance with ITA 18.1.
- 19.2 Applications submitted electronically (if permitted pursuant to ITA 17.1) shall be opened in accordance with the procedures specified in the **ISDS**.
- 19.3 The Employer shall prepare a record of the opening of Applications to include, as a minimum, the name of the Applicants. A copy of the record shall be distributed to all Applicants.

E. Procedures for Evaluation of Applications

20. Confidentiality

- 20.1 Information relating to the Applications, their evaluation and results of the Initial Selection shall not be disclosed to Applicants or any other persons not officially concerned with the Initial Selection process until the notification of Initial Selection results is made to all Applicants in accordance with ITA 28.
- 20.2 From the deadline for submission of Applications to the time of notification of the results of the Initial Selection in accordance with ITA 28, any Applicant that wishes to contact the Employer on any matter related to the Initial Selection process may do so only in writing.

21. Clarification of Applications

- 21.1 To assist in the evaluation of Applications, the Employer may, at its discretion, ask an Applicant for a clarification (including missing documents) of its Application, to be submitted within a stated reasonable period of time. Any request for clarification from the Employer and all clarifications from the Applicant shall be in writing.
- 21.2 If an Applicant does not provide clarifications and/or documents requested by the date and time set in the Employer's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

22. Responsiveness of Applications

- 22.1 The Employer may reject any Application which is not responsive to the requirements of the Initial Selection Document. In case the information furnished by the Applicant is incomplete or otherwise requires clarification as per ITA 21.1, and the Applicant fails to provide satisfactory clarification and/or missing information, it may result in disqualification of the Applicant.
- 23. Margin of Preference
- 23.1 Unless otherwise specified in the ISDS, a margin of preference for domestic Proposers¹ shall not apply in the RFP process resulting from this Initial Selection.

24. Subcontractors

- 24.1 Unless otherwise stated **in the ISDS**, the Employer does not intend to execute any specific elements of the Works Design and Build by sub-contractors selected in advance by the Employer (so-called "Nominated Subcontractors").
- 24.2 The Applicant shall not propose to subcontract the whole of the contract. The Applicant may propose subcontractors for certain specialized parts of the contract. Applicants planning to use such specialized subcontractors shall specify, in the Application Submission Letter, the parts of the contract proposed to be subcontracted along with details of the proposed subcontractors including their qualification and experience.

F. Evaluation of Applications and Initial Selection of Applicants

25. Evaluation of Applications

25.1 The Employer shall use the factors, methods, criteria, and requirements defined in Section III, Initial Selection Criteria and Requirements and the ISDS to evaluate the qualifications of the Applicants, and no other factors, methods, criteria, or requirements shall be used. The Employer reserves the right to waive minor deviations from the qualification criteria if they do

An individual firm is considered a domestic Proposer for purposes of the margin of preference if it is registered in the country of the Employer, has more than 50 percent ownership by nationals of the country of the Employer, and if it does not subcontract more than 10 percent of the contract price, excluding provisional sums, to foreign contractors. JVs are considered as domestic Proposers and eligible for domestic preference only if the individual member firms are registered in the country of the Employer, have more than 50 percent ownership by nationals of the country of the Employer, and the JV shall be registered in the country of the Borrower. The JV shall not subcontract more than 10 percent of the contract price, excluding provisional sums, to foreign firms. - 25.2 Subcontractors proposed by the Applicant shall be fully qualified for their parts of the contract. - 25.3 In case of multiple contracts, Applicants should indicate in their Applications the individual contract or combination of contracts in which they are interested. The Employer shall initially select each Applicant for the maximum combination of contracts for which the Applicant has thereby indicated its interest and for which the Applicant meets the appropriate aggregate requirements specified in Section III Initial Selection Criteria and Requirements.
- 25.4 However, with respect to the specific experience under item Section III (Qualification Criteria and Requirements), 4.2, the Employer will select any one or more of the options as identified below:

N is the minimum number of contracts

V is the minimum value of a single contract.

- 25.5 Only the qualifications of the Applicant shall be considered. The qualifications of other firms, including the Applicant's subsidiaries, parent entities, affiliates, subcontractors (other than specialized subcontractors in accordance with ITA 25.2 above) or any other firm(s) different from the Applicant shall not be considered.
- 26. Employer's Right to Accept or Reject Applicants
- 26.1 The Employer reserves the right to accept or reject any Application, and to annul the Initial Selection process and reject all Applicants at any time, without thereby incurring any liability to the Applicants.
- 27. Initial Selection of Applicants
- 27.1 The range of Applicants that the Employer may Initially Select (x=minimum number, y = maximum number) is specified in the ISDS.
- 27.2 Initial Selection of Applicants involves several steps, as follows:
 - (a) **Step 1 Table 1 Evaluation:** The first step of Initial Selection involves evaluation against the methods, criteria and requirements described in Section III, Table 1: Qualification Criteria and Requirements;
 - (b) **Step 2 Rejection:** Applicants that do not substantially meet the qualification criteria and requirements in Table

- 1: Qualification Criteria and Requirements will not be evaluated further, and will be eliminated from the Initial Selection process;

28. Notification of Initial Selection

- 28.1 The Employer shall notify all Initially Selected Applicants in writing that they have been Initially Selected. In providing this notification the Employer shall include the names of all Applicants that have been Initially Selected.
- 28.2 The Employer shall separately notify all other Applicants that they have not been Initially Selected, and that they have been eliminated from the process. Any Applicant that has been eliminated from the process at this stage may request, in writing, the grounds on which they were eliminated.

29. Request for Proposals

- 29.1 Promptly after the notification of the results of the Initial Selection, the Employer shall invite Proposals from all the Applicants that have been initially selected.
- 29.2 Proposers may be required to provide a Proposal Security or a Proposal-Securing Declaration acceptable to the Employer in the form and an amount to be specified in the RFP document.
- 29.3 The successful Proposer shall be required to provide a Performance Security as specified in the RFP document.
- 29.4 If applicable, the successful Proposer may also be required to provide a separate Environmental and Social (ES) Performance Security.
- 29.5 Proposers shall be required to provide a Code of Conduct which will apply to their and subcontractors' personnel that includes the minimum requirements specified in the RFP document.
- 29.6 The successful Proposer shall provide additional information about its beneficial ownership using the Beneficial Ownership Disclosure Form included in the RFP document.
- 29.7 If specified in the ISDS, the Employer intends to require Proposers to submit a Sexual Exploitation and Abuse (SEA) and/or Sexual Harassment (SH) Declaration, using the Sexual Exploitation and Abuse (SEA), and/or Sexual Harassment (SH) declaration form included in the RFP documents.
- 29.8 Prior to Contract award, the Employer will verify that the successful Proposer (including each member of a JV) is not disqualified by the Bank due to noncompliance with contractual SEA/SH prevention and response obligations. The Employer will conduct the same verification for each subcontractor proposed by the successful Proposer. If any proposed subcontractor does not meet the requirement, the Employer will require the Proposer to propose a replacement subcontractor

30. Changes in Qualifications of Applicants

30.1 Any change in the structure or formation of an Applicant after being initially selected in accordance with ITA 27 and invited to submit Proposal (including, in the case of a JV, any change in the structure or formation of any member and also including

any change in any specialized subcontractor) shall be subject to the written approval of the Employer prior to the deadline for submission of Proposals. Such approval shall be denied if (i) an initially selected applicant proposes to associate with a disqualified applicant or in case of a disqualified joint venture, any of its members; (ii) as a consequence of the change, the Applicant no longer substantially meets the qualification criteria set forth in Section III - Initial Selection Criteria and Qualification Requirements Table 1-Criteria, Requirements; or (iii) no longer continues to be in the list of Initially Selected Applicants as a result of the Employer's reevaluation of the Application in accordance with ITA 27; or (iv) in the opinion of the Employer, the change may result in a substantial reduction in competition. Any such change should be submitted to the Employer not later than fourteen (14) days after the date of the Request for Proposals.

31. Procurement Related Complaint

31.1 The procedures for making a Procurement-related Complaint are as specified in the ISDS.

1. Purpose

1.1 The Bank's Anti-Corruption Guidelines and this annex apply with respect to procurement under Bank Investment Project Financing operations.

2. Requirements

2.1 The Bank requires that Borrowers (including beneficiaries of Bank financing); bidders (applicants/proposers), consultants, contractors and suppliers; any sub-contractors, sub-consultants, service providers or suppliers; any agents (whether declared or not); and any of their personnel, observe the highest standard of ethics during the procurement process, selection and contract execution of Bank-financed contracts, and refrain from Fraud and Corruption.

2.2 To this end, the Bank:

 - v. "Obstructive practice" is:
 - (a) deliberately destroying, falsifying, altering, or concealing of evidence material to the investigation or making false statements to investigators in order to materially impede a Bank investigation into allegations of a corrupt, fraudulent, coercive, or collusive practice; and/or threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation; or
 - (b) acts intended to materially impede the exercise of the Bank's inspection and audit rights provided for under paragraph 2.2 e. below.
- b. Rejects a proposal for award if the Bank determines that the firm or individual recommended for award, any of its personnel, or its agents, or its sub-consultants, sub-contractors, service providers, suppliers and/ or their employees, has, directly or indirectly, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices in competing for the contract in question;

- c. In addition to the legal remedies set out in the relevant Legal Agreement, may take other appropriate actions, including declaring mis-procurement, if the Bank determines at any time that representatives of the Borrower or of a recipient of any part of the proceeds of the loan engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices during the procurement process, selection and/or execution of the contract in question, without the Borrower having taken timely and appropriate action satisfactory to the Bank to address such practices when they occur, including by failing to inform the Bank in a timely manner at the time they knew of the practices;
- d. Pursuant to the Bank's Anti-Corruption Guidelines, and in accordance with the Bank's prevailing sanctions policies and procedures, may sanction a firm or individual, either indefinitely or for a stated period of time, including by publicly declaring such a firm or individual ineligible (i) to be awarded or otherwise benefit from a Bank-financed contract, financially or in any other manner;² (ii) to be a nominated³ sub-contractor, consultant, manufacturer or supplier, or service provider of an otherwise eligible firm being awarded a Bank-financed contract; and (iii) to receive the proceeds of any loan made by the Bank or otherwise to participate further in the preparation or implementation of any Bank-financed project;
- e. Requires that a clause be included in request for bid/request for proposals documents and in contracts financed by a Bank loan, requiring (i) bidders (applicants/proposers), consultants, contractors, and suppliers, and their sub-contractors, sub-consultants, service providers, suppliers, agents, personnel, permit the Bank to inspect⁴ all accounts, records and other documents relating to the procurement process, selection and/or contract execution, and to have them audited by auditors appointed by the Bank.

For the avoidance of doubt, a sanctioned party's ineligibility to be awarded a contract shall include, without limitation, (i) applying for pre-qualification, expressing interest in a consultancy, and bidding, either directly or as a nominated subcontractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider, in respect of such contract, and (ii) entering into an addendum or amendment introducing a material modification to any existing contract.

A nominated sub-contractor, nominated consultant, nominated manufacturer or supplier, or nominated service provider (different names are used depending on the particular bidding document) is one which has been: (i) included by the bidder in its pre-qualification Application or bid because it brings specific and critical experience and know-how that allow the bidder to meet the qualification requirements for the particular bid; or (ii) appointed by the Borrower.

Inspections in this context usually are investigative (i.e., forensic) in nature. They involve fact-finding activities undertaken by the Bank or persons appointed by the Bank to address specific matters related to investigations/audits, such as evaluating the veracity of an allegation of possible Fraud and Corruption, through the appropriate mechanisms. 1. Description of the Works (Design and Road Rehabilitation)

1.1. The Project and its Contracts

Eastern and Western Regional Road Network Rehabilitation works in this Package 1 is part of the Mongolia Transport Connectivity and Logistics Improvement Project (the Project), expected to be financed through a loan from the International Bank of Reconstruction and Development (IBRD) for US\$100 million. This procurement of Package 1 includes following two Lots.

Ulaanbaatar-Undurkhaan Roads and Arvaikheer-Bayankhongor Roads are the main important sections of the State Road Network (Route A05 and A03 of the national road network), having the road numbers of A0501 and A0302 respectively, which connect Ulaanbaatar city, the capital of Mongolia to the other aimags in the Eastern and the Western region. The proposed road sections are located in the territories of Uvurkhangai aimag (in the west) and Khentii aimag (in the east). A map showing the locations of the Project Roads of Lot 1-1 and Lot 1-2 is displayed in Picture 1.



Picture 1. Locations of the Project Roads

However, some parts of the road sections are causing a bottleneck to the road traffic from the capital

city to the either eastern or western aimags due to the deteriorated and unsafe road conditions (poor condition IRI=6-8m/km or very poor condition IRI>8m/km). Therefore, improving the proposed roads will enhance the economic development and the regional link.

The rehabilitation works will be existing right-of-way, and will include passage of traffic, rehabilitation of existing road, drainage improvements, and installation of road safety facilities such as signs, markings, and wildlife crossings. The Contractor shall be responsible for the design, construction, completion and correction of defects of the Contract Works to meet all requirements and provisions of the Employer's Requirements.

The Conditions of the Contract will be the FIDIC Conditions of Contracts for Plant & Design-Build for Electrical & Mechanical Plant & for building & Engineering Works Designed by the Contractor ("Yellow book"), Second edition 2017.

The brief descriptions related to the project roads of Lot 1-1 and Lot 1-2 are provided in below.

1.2. Description of Works for LOT 1-1:

A0501 Ulaanbaatar-Undurkhaan 68 km road D&B and rehabilitation work

The Project Road of Lot 1-1 is located alongside the State Road Network No. 0501 Ulaanbaatar-Undurkhaan/Chinggis City between Km 99+000 and Km 333. Total 68 km roads to be rehabilitated.

Location map of the Project Road of Lot 1-1 in Picture 2 may give proper sight.

Detailed Engineering Design (DED) of the Rehabilitation works had been prepared by a Design Consultant in 2021 and State Expert Approval Notice had been issued on 22 April 2022. The Design Consultant, also, had conducted the Technical Condition Survey for entire 68 km of the project road of Lot 1-1 in 2021. Some considerable results mentioned in the Report of this Survey are given below:

- Geometric parameters of the road: 89% of width of road carriageway is sufficient
- However, 82.3% of shoulders are insufficient showing irregularity of cross slope and erosion
- Damages on the pavement surface are substantial i.e. crocodile cracks and potholes were occurred in 28,214.m² and 1281.60 m² respectively. Rutting and edge damages were occurred noticeably.

Pavement design proposed by the Design Consultant is:

- Asphalt concrete wearing course h=30mm
- Asphalt concrete binder course h=40mm
- Cement treated or Cement stabilized base course h=200mm
- Non-frost layer h=300mm

Cross section of the project road comprises 7.0m carriageway and 0.5m paved & shoulder, and 1.9m gravel shoulders at either side of the Road. The width is 11.8m in total.

As stated in the Project Technical Specifications prepared by the Design Consultant, the following

site works, but not limited to, shall be carried out:

- Site investigation and survey to review and assure data and records during the DED stage and refresh or/and update DED or data, if required.
- Construction and Rehabilitation or the required repair and maintenance for roads and culverts
- Rehabilitation of non-frost layer, Cement Treated Base (CTB) or Cement Stabilized Base (CSB)
- Laying of Asphalt wearing and binder course
- Road signs, markings and Road furniture,
- Drainage,
- Utility diversion,
- Road safety improvements,
- Street lighting,
- Landscaping, Environmental and Social mitigation enhancement schemes including community safety and wildlife crossings.


TOR for updating the Detail Engineering Design (DED) will be included with the Request for Proposal document for the initially selected applicants. DED shall be provided only for information purpose.

A brief description of the design update is as follows:

Objective(s) of the design review and update: The main objective for this assignment is to review and update the existing DED and Environment Impact Assessment (EIA). DED which is going to be shared with the initially selected bidders had been prepared in 2021. Since then, the conditions of the Project Roads might be deteriorated because they have been used for traffic. That's why, review and update of DED is necessary for ensuring desirable safety aligning with the requirements of the Highway Design Standard and E&S requirements of the WB.

The Contractor shall prepare all documents necessary for the approval and construction of the works. These documents include, but are not necessarily limited to, detailed drawings, specifications, bill of quantities, environmental impact assessment and cost estimates.

Field surveys and data collection:

- 1. Topographical survey shall be carried out in accordance with the provision of 6.1.3 of Law on Geodesy and Cartography of Mongolia, and Section II -Engineering geodetic works of "Civil structure engineering survey general requirements" BNbD 11-07-04 and "Geodetic works" BNbD 3.01.03-88.
- 2. Existing geological studies and investigations shall be reviewed and validated. If required, existing data and studies shall be complemented by additional geotechnical investigations and tests.
- 3. A new materials sources survey shall be undertaken, and shall present the test findings alongside the aggregate material properties shown in the specification to demonstrate compliance. The estimated quantities of materials identified shall meet the minimum quantity required for the project.

Detailed engineering design:

- 4. The detailed design shall conform to the design standards approved and adopted for the Project and shall incorporate the requirements and modifications resulting from the Environmental Assessment, Road Safety Audit, Climate Change Adoption, Archeological Assessment or Land Acquisition and Resettlement Assessment.

 - (iv) "Road Climate and Geotechnical Conditions" AZUAGN 2.01.01-2004,
 - (v) "Designing civil structures in seismic areas" BNbD 22.01.01*/2006,
 - (vi) "Railway and road tunnel design" BNbD 32-07-10,
 - (vii) "Civil structure engineering survey general requirements" Section II -Engineering geodetic works of BNbD 11-07-04 and "Geodetic works" BNbD 3.01.03-88,
 - (viii) "Road signs. Technical general requirements" MNS4597:2014,
 - (ix) "Road signs, signages, markings, signals, barriers and guide posts application" MNS4596:2014
- 6. The Contractor shall review and update the existing design based on the prevailing design standards and norms, following recommendations of MRTD, and the agreed design parameters.

Drawings, technical specification, quantities and cost estimate:

- 1. The Contractor shall prepare drawings, technical specifications, quantity and cost estimates, in compliance with MRTD and WB requirements as required for the proper execution of the Project.
- 2. The Contractor shall check and review the engineering drawings to ensure that all the design information is well articulated within the drawings. The Contractor, thereafter, shall prepare and update the design drawings incorporating any additional design changes that may be required (and or fill any gaps within the drawings).
- 3. Other supporting documents to be prepared by the Contractor shall include (but not limited to) the following:

- i. Topographic, geotechnical, and hydrological field survey reports
- ii. Material sources survey report
- iii. Design report
- 4. The materials sources survey report shall justify haulage distances assumed in the cost estimate.

Environmental impact assessment (EIA):

EIA shall be developed in accordance with the related requirements of the related laws and regulations and should be incorporated with the World Bank's Environment and Social Management Framework (ESMF). - (i) Environmental status assessment within the project area.
- (ii) Assessment of the environment in the territory where the project will be implemented.
- (iii) In the environmental state assessment report, the environmental state of areas that may be affected by the project (water environment, climate, geology, hydrogeology, geomorphology, climate conditions, air quality, soil, flora, fauna, etc.).

(iv) Identification of population and social conditions that may be affected by the project.

Environmental and Social Requirements by the Bank:

An awardee shall develop proper documents in accordance with the requirements of the World Bank ESS which is compulsory to the Project and ensure their compliance during the implementation.



A0302 Arvaikheer-Bayankhongor 35km road Rehabilitation

The Project Road of Lot 1-2 is located alongside the State Road Network No. 0302 Arvaikheer-Bayankhongor between Km 14+800 and Km 50+620 (35.82km). Picture 3 shows the location map of the Project Road of Lot 1-2.

Detailed Engineering Design (DED) had been prepared by the Design Consultant in 2021 and State Expert Approval Notice had been issued on 21 December 2021. The design consultant, also, had conducted the Technical Condition Survey for entire 35 km of the project road of Lot 1-2 in 2021. Some considerable results mentioned in the Report of this Survey are given below:

Geometric parameters of the road are irregular. Damage and cracks in the road pavement are substantial.

Pavement design proposed by the Design Consultant is:

- Asphalt concrete wearing course (fine) h=30mm
- Asphalt concrete binder course (coarse) h=40mm
- Cement treated or Cement stabilized base course h=200mm
- Non-frost layer h=300mm

Cross section of the project road comprises 7.0m carriageway and 0.5m paved & shoulder 1.5m gravel shoulders at either side. The Road width is 11.0m in total.

Almost 3 years have elapsed since the design was prepared, and no upgrading or maintenance work was done on that road; only routine maintenance was being done. Due to that condition, the

road may have deteriorated more, which requires an update to the existing design.

A brief description of the design update is as follows:

That's why, review and update of DED is necessary for ensuring desirable safety aligning with the requirements of the Highway Design Standard and E&S requirements of the WB.

The Contractor shall prepare all documents necessary for the approval and construction of the works. These documents include, but are not necessarily limited to, detailed drawings, specifications, bill of quantities, environmental impact assessment and cost estimates.

The scope of design review and update will comprise:

- 1. Preparation of documents suitable for approval as follows, but not limited to:
 - (i) Drawings in dual language (English / Mongolian)
 - (ii) Technical Specification in dual language (English / Mongolian)
 - (iii) Bill of Quantities in English with Mongolian translation
 - (iv) Priced bill of Quantities (the designer's cost estimate)
 - (v) Any other reference documents related to design scope.
 - (vi) Environmental Impact Assessment (EIA) in accordance with the Mongolia Law:
 - (vii) Obtain third party Expertise of the detailed design in accordance with the Law on Roads of Mongolia.
- 2. Modifications as follows:
 - (i) Review and update the existing detailed design and propose improvement of geometric parameters of the road (including longitudinal profile, curve radii, transition curves, etc.), which will be based on the actual road design standard ZZBNbD 22-004-2016;
 - (ii) Obtain all existing topographical, geological, geotechnical, hydrological data and studies and other surveys and carry out additional field surveys and tests necessary for preparation of detailed designs;
 - (iii) Preparation of new and updated detailed engineering designs for construction works;
 - (iv) Preparation of detailed engineering designs for additional features including bus stops with shelters, rest areas with toilets, and a toll gate / weigh station. This activity is to include survey, design and specification of civil works, utility supply, building works, and equipment,
 - (v) Preparation of detailed design for relocation of all the affected Utilities in agreement with the Utility Owner.

Field surveys and data collection:

- Topographical survey shall be carried out in accordance with the provision of 6.1.3 of Geodesy and Cartography Law of Mongolia, and Section II -Engineering geodetic works of "Civil structure engineering survey general requirements" BNbD 11-07-04 and "Geodetic works" BNbD 3.01.03-88.
- 1. Existing geological studies and investigations shall be reviewed and validated. If required, existing data and studies shall be complemented by additional geotechnical investigations and tests.
- 2. A new materials sources survey shall be undertaken, and shall present the test findings alongside the aggregate material properties shown in the specification to demonstrate compliance. The estimated quantities of materials identified shall meet the minimum quantity required for the project.

Detailed engineering design:

- 1. The detailed design shall conform to the design standards approved and adopted for the Project and shall incorporate the requirements and modifications resulting from the Environmental Assessment, Road Safety Audit, Climate Change Adoption, Archeological Assessment or Land Acquisition and Resettlement Assessment.
- 2. The following Mongolian design standards and norms shall be considered:
 - (x) Road Design" ZZBNbD 22-004-2016,
 - (xi) "Urban and Village Design and Construction" BNbD 30-01-04,
 - (xii) "Urban Street Design" BNbD 32-01-04,
 - (xiii) "Road Climate and Geotechnical Conditions" AZUAGN 2.01.01-2004,
 - (xiv) "Designing civil structures in seismic areas" BNbD 22.01.01*/2006,
 - (xv) "Railway and road tunnel design" BNbD 32-07-10,
 - (xvi) "Civil structure engineering survey general requirements" Section II -Engineering geodetic works of BNbD 11-07-04 and "Geodetic works" BNbD 3.01.03-88,
 - (xvii) "Road signs. Technical general requirements" MNS4597:2014,
 - (xviii) "Road signs, signages, markings, signals, barriers and guide posts application" MNS4596:2014
- 3. The Contractor shall update the existing design based on the prevailing design standards and norms, following recommendations of MRTD, and the agreed design parameters.

Drawings, technical specification, quantities and cost estimate:

- 1. The Contractor shall prepare drawings, technical specifications, quantity and cost estimates, in compliance with MRTD and WB requirements as required for the proper execution of the Project.
- 2. The Contractor shall check and review the engineering drawings to ensure that all the design information is well articulated within the drawings. The Contractor, thereafter, shall prepare and update the design drawings incorporating any additional design changes that may be required (and or fill any gaps within the drawings).
- 3. Other supporting documents to be prepared by the Contractor shall be include (but not limited to) the following:
 - iv. Topographic, geotechnical, and hydrological field survey reports
 - v. Material sources survey report

vi. Design report

- 4. The materials sources survey report shall justify haulage distances assumed in the cost estimate.
- 5. The calculated construction quantities shall be based on the final design drawings. The earthworks quantities shall be derived from calculations based on the field cross-sections taken along the road centerline in accordance with accepted methods of measurement. Bills of Quantities based on the various items of work to be executed in accordance with the Drawings and the work (pay) items specified in the Technical Specifications.

Environmental impact assessment (EIA):

EIA shall be developed in accordance with the related requirements of the related laws and regulations and should be incorporated with the World Bank's Environment and Social Management Framework (ESMF). An applicant may access to the World Bank's website for studying ES policy and Environmental and Social Standards (ESS) and 'Environmental and Social Management Framework (ESMF)" and "Environment and Social Commitment Plan (ESCP)" for Mongolia transport connectivity and logistics improvement project (P174806) which were prepared/updated by the MRTD in 2021 and 2023 respectively.

- 1. The environmental impact assessment includes the following activities:
- (ix) Prepare a report on the assessment of the current environmental status of the paved road construction route;
- (x) Presenting the work report of the assessment of the environmental condition to MRTD, local government and obtaining comments;
- (xi) Assist in the preparation of materials required for the general environmental assessment of the project, and assist in delivering the prepared materials to the Ministry of Environment and Tourism of Mongolia;
- (xii) Creating a detailed assessment of the project's environmental impact and developing a report;
- (xiii) Presenting the detailed environmental impact assessment work report to MRTD and asking for comments;
- (xiv) Presenting and discussing the detailed environmental impact assessment work report at the general meeting of citizens that are along the project route;
- (xv) Submit the detailed environmental impact assessment work report to the Ministry of Environment and Tourism of Mongolia, and obtain its approval;
- (xvi) Upload the detailed environmental impact assessment report to the Mongolian Environmental Assessment electronic database.
- 2. An environmental baseline survey and assessment will be carried out, including:
- (v) Environmental status assessment within the project area.
- (vi) Assessment of the environment in the territory where the project will be implemented.
- (vii) In the environmental state assessment report, the environmental state of areas that may be affected by the project (water environment, climate, geology, hydrogeology, geomorphology, climate conditions, air quality, soil, flora, fauna, etc.).
- (viii) Identification of population and social conditions that may be affected by the project.

Environmental and Social Requirements by the Bank:

A Contractor, who would be awarded for any Contract Lot of the Project after ISD and RFP procedure, shall carry out contractual responsibilities with the World Bank Environmental and Social Framework (ESF) and comply with the requirements of the World Bank Environmental and Social Standards (ESS) through the project life cycle, i.e. design, construction, rehabilitation, completion etc.

The ESS set out the requirements relating to the identification and assessment of environmental and social risks and impacts associated with projects in order to reduce poverty and increase prosperity in a sustainable manner for the benefit of the environment. Ten ESS establish the standards that the project will meet through the project implementation, as follows:

- ESS 1: Assessment and Management of Environmental and Social Risks and Impacts;
- ESS 2: Labor and Working Conditions;
- ESS 3: Resource Efficiency and Pollution Prevention and Management;
- ESS 4: Community Health and Safety;
- ESS 5: Land Acquisition, Restrictions on Land Use and Involuntary Resettlement;
- ESS 6: Biodiversity Conservation and Sustainable Management of Living Natural Resources;
- ESS 7: Indigenous Peoples/Sub-Saharan African Historically Underserved Traditional Local Communities;
- ESS 8: Cultural Heritage;
- ESS 9: Financial Intermediaries; and
- ESS 10: Stakeholder Engagement and Information Disclosure.

An awardee shall develop proper documents in accordance with the requirements of the World Bank ESS which is compulsory to the Project and ensure their compliance during the implementation.

2. Construction works

Given the need for a) survey and design updating and obtaining expertise appraisal of the design, b) logistics of the project location, and c) the short working season, the time for completion will be 24 months (i.e. covering 2 complete construction seasons).

Estimated construction schedule is:

Commencement: October 2024

- Completion: October 2026

- Time for completion: 24 months

- Defects notification period; 36 months

2. Implementation Period

The Time for Completion of the both Lot 1-1 and Lot 1-2 is Twenty-four (24) months plus Thirty-six (36) months Defect Notification Period.

3. Site and Other Data

More detailed information about the site and other data will be provided with the Request for Proposal document for the initially selected applicants.

4. Environmental and Social (ES) Requirement

- 1. The environmental risk of the project is proposed to be **substantial.** Repair and maintenance of project roads in selected aimags pose the following environmental risks during construction, as per Bank's the Environment and Social Framework, including fugitive dust; noise; construction waste; soil erosion and runoff; occupational health and safety (OHS) impacts on workers and communities; traffic and road safety problems; potential biodiversity risks. These risks are expected to be temporary, site specific, and manageable through the mitigation hierarchy. The operation of roads will have positive impacts to the economy after the road conditions improve but may have negative impacts to biodiversity if not well designed.
- 2. The social risk of the project is considered **substantial**. The Project proposed activities include road maintenance, paving last-mile roads in selected aimags. Risks and impacts are identified in the following aspects: labor and working conditions, community health and safety, meaningful consultation about impact on livelihoods associated with restrictions to land use, the inclusion of ethnic minority groups, and overall stakeholder engagement process.
- 3. All project activities will be implemented on existing roads or in locations that have no livelihoods impact. As a result, no land acquisition is envisaged. To confirm that no livelihoods impact will occur to local communities, stakeholder engagement will be key for the last-mile sections. In addition to road alignment, the sourcing of materials will be studied to assess any possible impacts on livelihoods of gathering and transporting materials. Inclusion will be considered when designing sanitation facilities if required, for example universal access, and safety for women.
- 4. An Environmental and Social Management Framework (ESMF) has been prepared to cover all project-supported activities, including repair and maintenance of existing roads, upgrading of last-mile roads, technical assistance and CERC activities, and any associated facilities, all in compliance with both domestic regulations and the World Bank's Environmental and Social Framework. The ESMF, as described in Environmental and Social Standard 1, has spelled out the principles, rules, guidelines, and procedures for the assessment of E&S risks and impacts. This ESMF also establishes screening criteria for subprojects to exclude high E&S risk activities from project financing. During implementation, the Project Management Office (PMO) of MRTD will conduct specific E&S risk assessment and screening for all the project activities per ESF policy requirements. Based on the screening, the associated E&S risks/impacts will be identified together with needed E&S instruments which should be additionally prepared, implemented and monitored following domestic laws and regulations and the World Bank's ESF policy.
- 5. To mitigate the potential risks to wild animals and cultural heritage sites, field survey including biodiversity investigation and cultural heritage survey will be conducted, and an ESMP/ESMPs for the last mile roads will be prepared and incorporated with mitigation measures to protect biodiversity and potential heritage sites including an BMP if necessary, before bidding of the roads. The requirements of the ESMP(s) will be integrated into the bidding documents and the contracts, which have been incorporated into the ESCP.
- 6. The Environmental and Social Standards, together with their Annexes, which set out the mandatory requirements that apply to the projects funded by the World Bank. That's why proper documents meeting with the requirements of those standard have to be prepared and complied with through the project life cycle. Those ESS are as follows:
 - ESS 1: Assessment and Management of Environmental and Social Risks and Impacts;
 - ESS 2: Labor and Working Conditions;
 - ESS 3: Resource Efficiency and Pollution Prevention and Management;

- ESS 4: Community Health and Safety;
- ESS 5: Land Acquisition, Restrictions on Land Use and Involuntary Resettlement;
- ESS 6: Biodiversity Conservation and Sustainable Management of Living Natural Resources;
- ESS 7: Indigenous Peoples/Sub-Saharan African Historically Underserved Traditional Local Communities;
- ESS 8: Cultural Heritage;
- ESS 9: Financial Intermediaries; and
- ESS 10: Stakeholder Engagement and Information Disclosure.
- 7. MRTD has developed an SEP (as part of the ESMF) and an ESCP which should be both implemented and updated if necessary throughout the project implementation.
